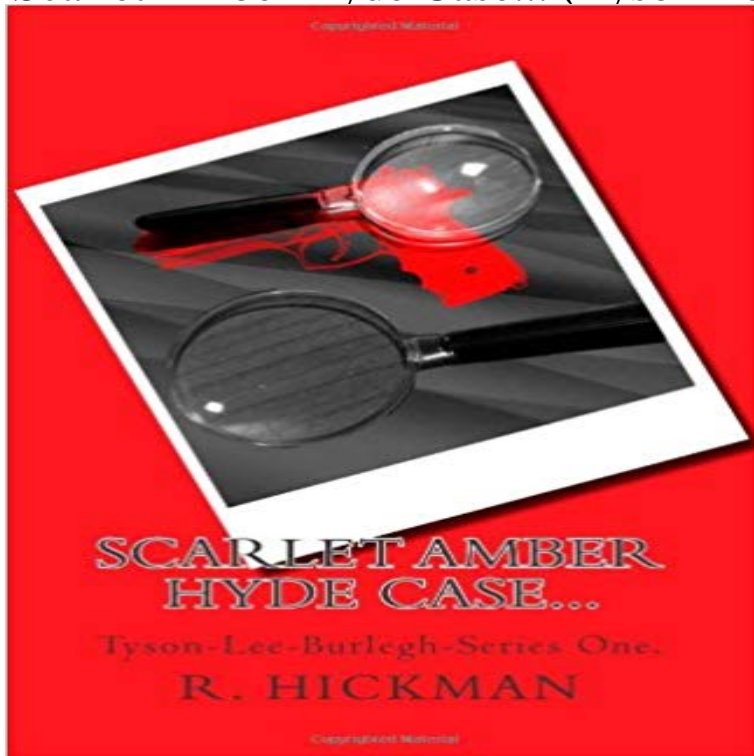


Scarlet Amber Hyde Case... (Tyson-Lee-Burleigh)
