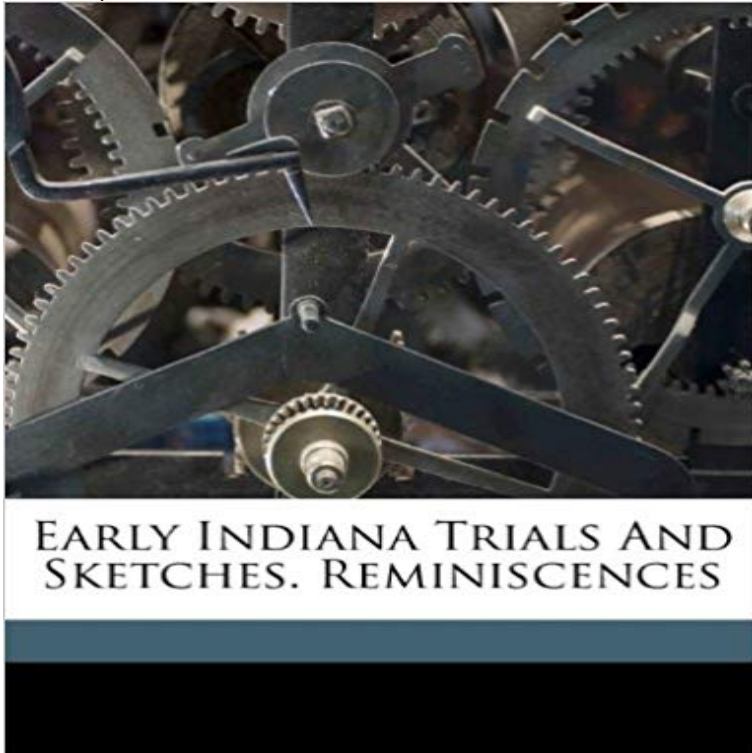


Early Indiana trials and sketches. Reminiscences
