Although Dr. Seifers testimony in court proved that Rosati was in Rhode Island when Viscido was killed, it wasnt enough to deter Florida police from trying to pin the murder on Rosati. Thus began the longest extradition hearing in U.S. history and a powerful criminology case study in police misconduct, mishandled evidence, and wrongful prosecution. With access to over 1,500 pages of police logs, 1,400 pages of court transcripts, and countless depositions and interviews, Seifer weaves a thrilling story of one mans battle for justice.
