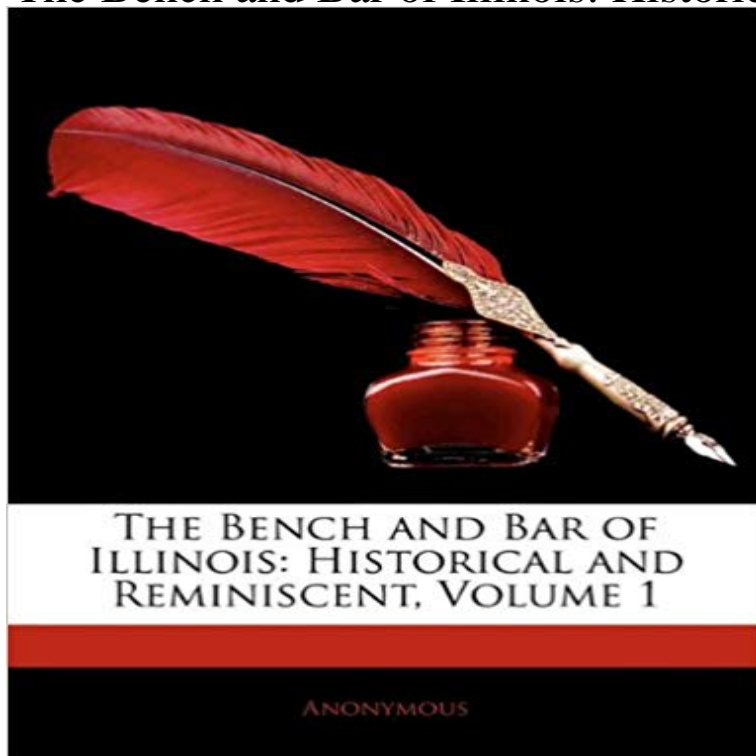


The Bench and Bar of Illinois: Historical and Reminiscent, Volume 1
