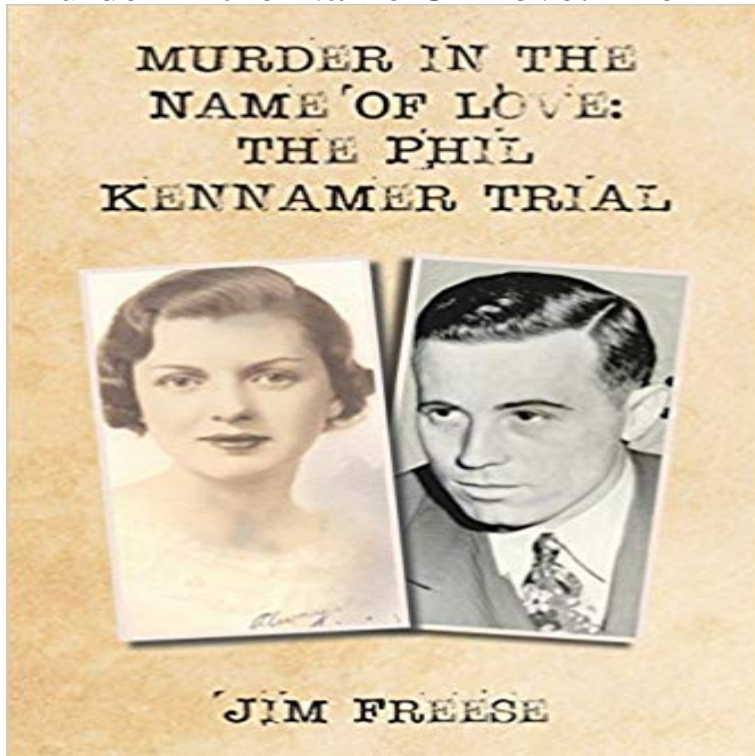


## Murder in the Name Of Love: The Phil Kennamer Trial
